**Subject: Notification under Art. 19 (3) of Regulation (EU) N° 596/2014 of the European Parliament and of the Council of 16 April 2014**

**Dear ladies and gentlemen,**

We hereby and within the statutory term inform you that the Company's office has received a notification under Art. 19 (1) of Regulation (EU) N° 596/2014 of the European Parliament and of the Council of 16 April 2014, as follows:

- On June 3, 2026, Starcom Holding AD purchased through 3 stock exchange transactions 3,948 bonds from an issue with ISIN BG2100002224 of Eurohold Bulgaria AD;
- On June 3, 2026, Starcom Holding AD purchased 1 bond from an issue with ISIN BG2100013205 of Eurohold Bulgaria AD;
- On June 5, 2026, Starcom Holding AD sold 694,445 shares of Eurohold Bulgaria AD under a repo agreement at a unit price of EUR 0.720 per share.

According to the terms of the agreement, the maturity date is December 4, 2026, and the redemption will be carried out at a price of EUR 0.743 per share.
